

**PRODUCERS FOR PROGRESS
OFFICIAL RULES**

1) ELIGIBILITY: The **PRODUCERS FOR PROGRESS RECOGNITION PROGRAM** ("Program") is open only to customers of Boehringer Ingelheim mastitis treatment products* who are legal residents of the 50 United States and the District of Columbia, and who are at least eighteen 18 years of age or older at time of application. The following individuals are not eligible to enter or win: employees and contractors of Boehringer Ingelheim Animal Health (BI) or its affiliates, and their immediate family members (spouse, parent, child, sibling and their respective spouses); those living in the same household of each (whether legally related or not) and previous Producers for Progress award winners. 4) RECIPIENT SELECTION: Up to three dairy producers will be selected by an expert panel of judges to receive this recognition on or about Oct. 1, 2018, from among all eligible applications received throughout the Program Period. Recipients will be judged based on the following selection criteria: a) demonstrated understanding of and passion for judicious use of antibiotics, b) commitment to animal well-being, and c) customer of at least one BI mastitis product. *Mastitis products that qualify for this Program are: ToDAY® (*cephapirin sodium*), ToMORROW® (*cephapirin benzathine*), PolyMast™ (*hetacillin potassium*), Dry-Clox® (*cloxacillin benzathine*) by BI and Lockout™ by Merial. Merial is now a part of Boehringer Ingelheim. PolyMast is a trademark of and DRY-CLOX, ToDAY and ToMORROW are registered trademarks of Boehringer Ingelheim Vetmedica, Inc. Lockout is a trademark of Merial.
